TERMS AND CONDITIONS OF ACCOUNT

- 1. <u>Credit Covered</u>. This Application covers any type of credit now or hereafter extended to Applicant by SITECH Chesapeake LLC (hereinafter "SITECH") including, but not limited to, any advance, loan, lease, sale on account, conditional or installment sale, or financing arrangement.
- 2. <u>Application of Payments</u>. Applicant authorizes SITECH, in its sole discretion, to apply any payments or property received in connection with any agreement, contract, lease, or account between Applicant and SITECH to any obligation between them.
- 3. <u>Cross-Default of Obligations</u>. In addition to and not in substitution of the provisions of any agreement, contract, lease, or account between Applicant and SITECH, any default in the payment or performance of any obligation is a default under each such agreement, contract, lease, or account.
- 4. <u>Accuracy of Information</u>. The information given in this Application is correct and material to granting credit. Applicant shall notify SITECH of any material change in the information set forth in, or furnished in connection with, this Application.
- 5. <u>References</u>. Applicant authorizes SITECH to contact any of the references identified in this Application and further authorizes each reference to disclose to SITECH, it representatives and agents all information the reference may have relating to Applicant.
- 6. <u>No Obligation</u>. Neither execution of, nor anything contained in, this Application shall obligate SITECH to extend credit, sell goods or equipment, or provide service to Applicant. SITECH may, in its sole discretion, agree or refuse to extend credit, sell goods or equipment, or provide service to Applicant.
 - 7. Authority. The person signing this Application is authorized to sign on behalf of Applicant.
- 8. <u>Liability if Not Incorporated or Formed</u>. If Applicant is not incorporated or formed when this Application is submitted to SITECH, Applicant, upon becoming duly incorporation or formed, shall be jointly and severally liable with the person signing this Application for all indebtedness then outstanding.
- 9. <u>Damage Waiver</u>. Applicant hereby **WAIVES**, regardless of cause, any claim whatsoever against SITECH for any incidental or consequential damages, including without limitation, property damage, personal injury, loss of time, profits or income, or loss due to late delivery of parts or equipment, or loss due to improper, inadequate, untimely or lack of service.
- 10. <u>Service or Late Charges</u>. Unless otherwise agreed, SITECH shall have the right to impose service or late charges on any amount past due at SITECH's then prevailing rate.
- 11. <u>Collection Expenses</u>. If Applicant's account is past dues or Applicant is otherwise in default of its obligations to SITECH, Applicant shall be liable for all expenses (including, without limitation, attorney's fees) actually incurred by SITECH to collect the past due amounts or exercise any rights and remedies available to SITECH under applicable law, whether or not litigation is commenced.
- 12. <u>Governing Law, Jurisdiction and Venue</u>. Unless otherwise provided in an agreement, contract or lease between Applicant and SITECH: (a) this Application shall be governed by and interpreted in accordance with the laws of the State of Maryland, without regard to conflict of law principles; and (b) Applicant hereby submits to the jurisdiction of the Maryland courts and waives any defense to lack of venue in any Maryland court.
- 13. <u>Confession of Judgment</u>. If Applicant's account is past due or Applicant is otherwise in default of its obligations to SITECH, Applicant authorizes any attorney to appear on Applicant's behalf in one or more proceedings in any court having jurisdiction, or before any clerk, prothonotary or other court official, and CONFESS JUDGMENT AGAINST APPLICANT, WITHOUT APPLICANT HAVING PRIOR NOTICE OR OPPORTUNITY FOR PRIOR HEARING, for any amounts due SITECH, plus court costs and attorneys' fee of fifteen percent (15%) of the total amount then due. To the extent permitted under applicable law, Applicant waives: (a) all rights of exemption, homestead or appeal; and (b) all rights to relief from inquisition, levy, immediate execution, or other post-judgment remedies and enforcement actions. SITECH may confess judgment against Applicant on one or more occasions, from time to time, in the same or different jurisdictions.
- 14. WAIVER OF JURY TRIAL. APPLICANT HEREBY WAIVES ANY RIGHT APPLICANT MAY HAVE TO A TRIAL BY JURY IN ANY ACTION BROUGHT BY OR AGAINST SITECH.
